

Report on Factual Findings

To Wallenstam AB, registration number 556072-1523

We have performed the procedures agreed with you and enumerated below with respect to the below pre-defined examination items. Our engagement was undertaken in accordance with *SNT 4400* "*Uppdrag att utföra granskning enligt särskild överenskommelse rörande finansiell information*¹" applicable to agreed-upon procedures engagements. The procedures were performed solely to assist you to demonstrate to investors, upon request, that the accompanying portfolio of Eligible Projects and Assets as of 31 December 2020 for Wallenstam AB ("Wallenstam") exists and have been approved and that net proceed from Green Bonds issues have been credit to a special account and used exclusively on approved projects/assets. The procedures performed are summarized as follows:

- 1) We have for each Green Bond issued agreed that an amount equal to the net proceeds of the issue was credited to a special account (the "Green Account") in accordance to Wallenstam Green Bonds Framework.
- 2) We have for each Green Bond issued agree that an amount equal to the net proceeds of the issue was used exclusively on project/assets that comply with the categories and criteria's set out in Wallenstam Green Bonds Framework.

We report our findings below:

With respect to item 1) we found no exceptions.

With respect to item 2) we found no exceptions.

Because the above procedures do not constitute either an audit or a review made in accordance with International Standards on Auditing or International Standards on Review Engagements (or relevant national standards or practices), we do not express any assurance on numbers or their prerequisites.

Had we performed additional procedures or had we performed an audit or review of the financial statements in accordance with International Standards on Auditing or International Standards on Review Engagements (or relevant national standards or practices), other matters might have come to our attention that would have been reported to you.

The standard is based on the International Standard on Related Services, ISRS 4400, except for references to Swedish conditions.
